Important Note-

1. The application form filled earlier (for the post of Food Analyst) by the candidates in response to the RUHS notification no 18577 dated 17/09/2013 will NOT be considered now (except the application form fee). All such candidates are required to fill fresh application form.

2. The candidates who applied in response to the RUHS earlier notification no 18577 on dated 17/09/2013 will be considered eligible to apply in response to current RUHS notification no 24998 dated 09/03/2018.

APPLICATION FEE

All candidates have to pay non-refundable application fee of Rs. 3000/- **(Rs. 1500 for SC, ST category of Rajasthan state domicile)** on-line mode of payment.

The application fee is neither refundable, nor transferable and nor adjustable for any other recruitments. Any plea in this matter shall not be entertained.

The candidates

Who had paid the application form fee earlier for the post of FOOD ANALYST in response to the RUHS notification no 18577 dated 17/09/2013

are also required to fill fresh application form now. However, such candidates are not required to pay the application form fee again.

ELIGIBILITY CRITERIA

1. Educational Qualification

A person shall not be qualified for appointment as Food Analyst under the Act unless she / he

(i) holds a Masters degree in Chemistry or Biochemistry or Microbiology or Dairy Chemistry or Food Technology, Food and Nutrition or holds Bachelor of Technology in Dairy/Oil or holds degree in Veterinary Sciences from a university established in India by law or is an Associate of the Institution of Chemists (India) by examination in the section of Food Analysts conducted by the Institution of Chemists (India) or any other equivalent qualification recognized and notified by the Central Government for such purposes and has not less than 3 years experience in the analysis of food; and

(ii) has been declared qualified for appointment as a Food Analyst by a board appointed and notified by the Authority.

Notwithstanding anything contained above,-

(a) any Person who has been declared qualified for appointment as Public Analyst by the board constituted under Prevention of Food Adulteration Act, 1954 shall also be eligible for holding the post of Food Analyst.

(b) any person who is a Public Analyst under the provisions of Prevention of Food Adulteration Act, 1954 on the date of commencement of these Rules, may hold office of the Food Analyst subject to the terms and conditions of service applicable to such Person.

2. Other qualification

Knowledge of Hindi language in devnagri script (lipi)

Knowledge of Rajasthan 'sanskriti' in devnagri script (lipi)

3. Age limit

Minimum 22 years and maximum 45 years as on the date of Food Analyst Recruitment Examination.

The relaxation in upper age limit for reserved category candidates in Rajasthan shall be applicable as per state government rules.(ARTHANA available at the website)

APPLICATION PROCEDURE

Before filling the on-line application form, read the notification, information booklet etc. carefully. Ensure the eligibility and other requirements / criteria for recruitment as given in this booklet / ARTHANA.

You should be very careful in filling-up the on-line application form. If any lapse is detected during the scrutiny, your candidature will be rejected even if you come through the final stage of recruitment process or even at a later stage.

IMPORTANT: HAND WRITTEN / TYPED / PHOTOSTAT COPIES / PRINTED APPLICATION FORM / SCREEN PRINTOUT WILL NOT BE ENTERTAINED.

1. Copy of photo ID (driving license/PAN card /Voter ID /AADHAR/ Govt. of PSU card /Passport)
2. Date of birth certificate: 10th class certificate or any other equivalent certificate showing the date of birth.
3. Degree of qualifying examination.
4. Caste certificate (SC, ST, Non creamy layer OBC, non creamy layer MBC) issued by the competent authority, if applicable.
5. LD certificate /PH certificate issued by competent authority, if applicable.
6. Ex-serviceman certificate competent authority, if applicable.
7. Widow, divorcee certificate , if applicable.
8. Marriage Certificate, if applicable
9. Domicile certificate by the competent authority, if applicable.
10. Certificate for mandatory qualification as per ARTHANA.

13. N.O.C from present employer, if applicable.
14. Attempt certificate of UG examination.
15. Attempt certificate of PG examination.
16. 4(Four) Passport size photo.

17. Any other relevant certificate(s)/document(s)

EXAMINATION

The syllabus for the on-line examination is available at the RUHS website.

The date of on-line examination shall be 18.05.2018.

There shall be 100 multiple choice questions of one mark each. There shall be no negative marking.

The RUHS reserves the right to create cities / centre(s) for examination and also to call the candidates for the examination at any city / centre.

The details relating to conduct of the examination shall be available at the RUHS website in due course.

Candidates trying to use unfair means shall be disqualified from the recruitment. No correspondence whatsoever will be entertained from the candidates.

You should make sure of your eligibility to the post and that the declaration made by you in the format of application regarding your eligibility is correct in all respects. You will be liable to any legal action and / or termination from the services as may be deemed fit by the appointing authority, Govt. of Rajasthan, Jaipur in case it is found that you have furnished in-correct information or made false declaration regarding your eligibility at any stage or suppressed any information.

The jurisdiction for legal cases arising out of the recruitment process shall be limited to the competent courts at Rajasthan only.

The decision of the RUHS in all aspects and all respects pertaining to the application and its acceptance or rejection as the case may be, conduct of examination and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned.
